INDUSTRY TERMS

IR35: UK tax legislation determining whether a contractor should be taxed as an employee, based on the nature of their working arrangement.

CIS (Construction Industry Scheme): An HMRC scheme requiring tax deductions from payments made to construction subcontractors.

Umbrella Employment: A PAYE employment solution where Brookson employs the contractor directly and invoices the client, without the contractor needing to run their own limited company.

PSC (Personal Service Company): A limited company set up by a contractor to provide their services, distinct from operating as a sole trader.
